Health & Safety Protocols

Updated February 24, 2023

As our nation and world move beyond the COVID-19 pandemic, we wish to offer less restrictive protocols reflecting high vaccination rates among our staff and travelers, fewer restrictions put forth by the places we visit, and lower infection rates. *Sports Leisure Vacations* reserves the right to change these protocols when mandated by any governmental agencies with jurisdiction over our industry and/or destinations we visit.
